ur men's October retreat at the UM Camp in Wrightwood, Calif., closed with breakfast and a beautiful outdoor Communion service.

I asked God to send the Holy Spirit to make me aware that doubt can breed a desire to trust Him, ultimately bringing me to a "thin place" where I am closest to God.

I surrendered my will to God, to follow Him where He wants me to go, and do what He asks me to do.

I came away from the retreat renewed in my focus on life and stronger in my belief in God, my brothers in Christ, and in myself. Gratefully, I can now confidently ask, "Where do I go now, Lord? What do you want me to do?"
